(or how to use the marxist conflict paradigm to divide and destroy anything!)




# Marxism creates victim class of most any group by dividing society into winners and losers

Karl Marx set out a conflict paradigm of dividing society into winners and losers and framing society as a zero-sum game to accelerate revolution. He used economic class as the wedge of division, but that isn't the only way you can divide people and turn them on each other - almost any characteristic or stratification which exists in society can and has been used: Race, gender, sexuality, even health, weight or normality.

This conflict paradigm shows up in almost every activist movement these days and the narrative that fuels the conflict is essentially a repeat of Marx's original assertion, so much so that you can play a game of "Mad-Libs" with them and see how they all fit the pattern.



Starting with the **Communist Manifesto** direct from the mouths of Carl Marx and Friedrich Engels and note the key words which can then be replaced by any "idea" that seeks to create classes of winners and losers.



The strategy is to identify the answers to these seven questions, insert them into the manifesto and you will birth a new victim ideology.






